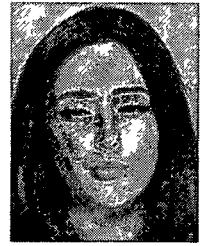

Before me this date personally appeared PESANTES, JUAN (10991) who being first duly sworn deposes and says that on 30 day of October, (year) 2021 at 1 SEMINOLE WAY, HOLLYWOOD, FL 33021 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows
leave property. I then made contact with Migirov. I then explained to Migirov the reason why I was making contact with her. Williams than issued another 24hr Trespass in my presence.

Migirov understood and started walking towards the front of the Casino. Migirov then attempted to go back inside the Hard Rock through a different entrance.

During a search incident to arrest, I located a clear bag inside her luggage that contained marijuana. I then tested using my department-issued drug test kit and came back positive for marijuana (pre package weight 19.54g, post package weight 29.36g).

Migirov was then placed under arrest for Trespass after warning, and possession of cannabis under 20 grams.

My department issued AXON body worn camera was activated during this incident.
