The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 The affiant was traveling south bound I-275. The affiant observed a white motor vehicle traveling at a high rate of speed. The vehicle swerved in front of the affiant, moved over to the left lane without signaling and cut off the affiant's path of travel where the affiant had to apply his brakes to evade striking the vehicle. The vehicle then quickly moved back in to the center lane cutting off a vehicle in front of the affiant. The defendant's driving was erratic and dangerous for other drivers on the roadway. The affiant noticed the driver was operating his motor vehicle in a willful disregard for the safety of persons and property. The affiant attempted to initiate a traffic stop utilizing overhead lights at which point, the defendant ignored and continued to swerve through traffic. The affiant then activated his siren and observed the vehicle following dangerously close to a vehicle in front of him in the center lane. The defendant then moved quickly to the left lane then back to the center while the affiant was following him with his overhead lights and siren on. Moments later, the defendant stopped and a traffic stop was conducted.

The affiant was approached by the victim and was notified that her vehicle had been struck by the defendant's motor vehicle causing property damage and the defendant had fled the scene. The distinct odor of an alcoholic beverage was detected on the defendant's breath. The defendant's eyes were bloodshot/glassy and the speech was slurred. The defendant admitted to consuming alcoholic beverages. The defendant exhibited clues of impairment during field sobriety exercises via the horizontal gaze nystagmus, the walk and turn, and one leg stand, and was taken into custody. It should be noted post arrest and after performance of field sobriety exercises the defendant refused to provide a breath sample.

The defendant was positively identified via DHSMV photograph.
