The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did

On January 8, 2022, I was dispatched to a vehicle crash that occurred on Interstate 4, eastbound near Mile Marker 2. Upon arrival, I observed a white Ford Escape bearing Florida tag number (NQAY64) and a gray Chevrolet Monte Carlo bearing Florida tag number (PDPZ35).

The driver of the Ford was identified by her Florida driver's license (N400-007-03-632-0) as Aryanna Grace Neill. When speaking to her I observed several signs of impairment. Her speech was mumbled and slurred. There was an odor of an alcoholic beverage emitting from her breathe as she spoke. Her eyes were also bloodshot red and glassy. When talking to her about the crash, she was crying and moody.

The passenger in the Ford Escape was identified by his Florida driver's license (D620-557-99-426-0) as Matthew Shane Drake. When speaking to him about the crash, he advised that the driver consumed approximately 4 or 5 shots prior to the crash. He was unable to advised how big or what type of shots she was drinking.

The driver of the Chevrolet was identified by his Florida driver's license (D242-521-95-146-0) Luis Alberto Diaz Alicea. He advised that as he was traveling east on Interstate 4, his vehicle was struck in the rear by the white Ford Escape. There were multiple witnesses to the crash, and they all advised that the Ford Escape appeared to be traveling at a high rate of speed before and at the crash occurred. Each witness also advised that they observed Aryanna Grace Neill in the driver seat when they approached the vehicle.

When I spoke with Hillsborough County Sheriff's Office Deputy on scene, he advised me that he observed Aryanna Grace Neill in the driver's seat of the Ford Escape and that he could smell the odor of an alcohol on her.

After clearing the crash scene, I proceeded to the Tampa General Hospital to follow up with Aryanna Grace Neill. When speaking to her, I observed that her eyes were still bloodshot red and glassy. Her speech was mumbled and slurred. I could also smell the odor of an alcoholic beverage emitting from her breathe as she spoke. Her hand movements were also sluggish and her responses to my questions were slow.

Upon getting medically discharged from the hospital, I advised her that I was finished with the crash investigation and starting a DUI investigation. She was read Miranda Rights and did not invoke her rights. When questioning her, she admitted to operating the Ford Escape at the time of the crash. She also admitted to consuming 3 Vodka in Downtown Tampa with a friend at around 10:00 PM. After questioning her, she was requested to perform standardized field sobriety exercises and consented.

Based on her performance on the field sobriety exercises, my observations, and the totality of circumstances, she was placed
