The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did

The defendant was driving a white 2019 Jeep Cherokee (NY Tag #JHL2676), when she pulled out of a parking lot and drove in the wrong direction (eastbound) on Cleveland St W, which is a 1-way road with westbound traffic only. While stopping the vehicle, she reversed up and over the concrete curb, accelerated in reverse through the parking lot and slammed on her brakes, narrowly missing a fence post and another parked vehicle.

During the traffic stop for the wrong way infraction, the defendant was identified via a NY DL and exhibited several clues of impairment, to include: watery/bloodshot eyes, blank/dazed stare, avoided eye contact, slurred speech, fumbling fingers when removing her license from her wallet, she was confused with directions, she admitted to drinking alcohol prior to driving, and emitted a distinct odor of an alcoholic beverage from her breath.

Following a poor performance on SFSEs, the defendant was arrested for DUI and transported to booking.

While at CBT, the defendant initially agreed to take a breath test, but then changed her mind and refused. I read her Implied Consent, and she confirmed that she did not want to take the test. I then processed her for a refusal.
