The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 1/17/2022, at 0218 hours, Deputy M. Rivera ABN:255038 and the affiant were running traffic. Deputy M. Rivera observed a black Ford bearing FL LVJU65 (VIN: 1FMCU0JX5EUA12265) traveling northbound on Dale Mabry HW N. The black Ford was measured traveling 70MPH in a posted 45MPH zone via Deputy M. Rivera's traffic enforcement. The affiant conducted a traffic stop on the vehicle at Dale Mabry Hw N / Minnehaha St W and observed the defendant operating the vehicle. The Affiant detected signs of impairment, the distinct odor of an alcoholic beverage emanating from the defendant's breathe, she had glassy eyes, slurred speech, and unsteady balance. The Affiant requested the defendant perform Standardized Field Sobriety Exercises (SFSEs) which the defendant agreed to do. During the SFSEs, the defendant showed multiple signs of impairment and was subsequently arrested for driving under the influence (DUI). After a proper 20-minute observation was completed, the defendant agreed to provide a lawful breath sample to determine her breath alcohol content (BrAC). Breath Technician Kirkland (ABN: 255300) provided me with the defendant's BrAC results and they are as follows: First BrAC sample .194; Second BrAC sample .192. The defendant was identified via FL DL.
