Before me this date personally appeared LYLE JUSTIN M (19625) who being first duly sworn deposes and says that on 23 day of April, (year) 2022 at 3208 SE 11TH ST 202 POMPANO BEACH FL 33062 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

defendant left her phone at his house while she was over there. [REDACTED] searched around his residence and was able to locate the defendant's phone in the garbage can inside his bathroom [REDACTED] then called the landlord back stating he found the defendant phone A few minutes later the defendant returned back to [REDACTED] residence with a metal frying pan to retrieve her phone [REDACTED] stated while trying to give the defendant back her phone the defendant swung a metal frying pan and hitting [REDACTED] on the back of his head causing swelling. [REDACTED] explained he fell to the floor and got up quickly [REDACTED] then stated the defendant swung the frying pan again when he got up hitting the left side of [REDACTED] nose which caused a small laceration The defendant did commit the crime of Battery Dating Violence as a result of this incident.
