The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did

On 03/18/2022, at approximately 0010 hours, Deputy M. Rock (ABN 260925) conducted a traffic stop at Rhodine Rd / Elnora Dr on a black Toyota sedan, bearing FL tag 63AXZF (VIN: 4T1C11AK1MU520475), for failing to stop at a stop sign. Deputy M. Rock observed the Defendant operating the vehicle and observed her to have bloodshot, watery eyes, slurred her speech and detected the odor of an alcoholic beverage emanating from her breath. The Affiant responded to the scene, detected an odor of an alcoholic beverage emanating from the Defendants breath, her eyes were bloodshot, water/glassy, her speech was slurred, and she was unsteady on her feet. The Affiant requested the Defendant perform Standard Field Sobriety Exercises (SFSEs) which she agreed to do. During the SFSEs, the Defendant showed multiple signs of impairment and was subsequently arrested. The Defendant initially agreed to provide two lawful breath samples to determine her breath alcohol content (BrAC) but later refused when asked again by stating "fuck no". The Defendant refused to get out of her chair to go into room 1 of CBT to be read implied consent and when the Affiant grabbed hold of her arm to assist her up, she resisted by grabbing onto the chair and refusing to stand up. The defendant continued yelling profanities and was escorted to booking. The defendant was identified verbally and via DAVID. During a search in DAVID the Affiant discovered the defendant has a suspended license as of 06/03/2019. The defendant was given a DUI citation AFYJJ1E which reflects the DUI charge and one UTC AFYERAE for DWLS 1st violation.
