The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did The defendant was operating a blue 2009 Mini Cooper, 2 door, Florida tag 41ARUW. The defendant drove in a manner in which she stopped in the roadway without cause, stopped well short of the painted stop line at a stop sign, failed to come to a complete stop for two properly posted stop signs, stopped beyond the painted white stop line at a properly posted stop sign, was weaving in the travel lane, and had delayed reactions to changing roadway characteristics. A traffic stop was conducted for running a stop sign and for the purpose of checking the welfare of the driver to determine if she were sick, tired, or impaired. The defendant had a strong and distinct odor of an alcoholic beverage on her breath. The defendant's eyes were bloodshot, glassy, and watery. The defendant's face was flushed, and her speech was mildly slurred. The defendant stated she drank one alcoholic drink tonight. Three empty cans of Twisted Tea (alcoholic beverage) were observed in plain view in the vehicle, and there was splashed liquid on the driver side door, dashboard area, and door molding. The defendant had difficulty recalling and reciting certain information. The defendant was unsteady exiting the vehicle, her gait was unsteady, and she swayed while standing. The defendant agreed to perform Field Sobriety Exercises. The defendant exhibited signs and clues of impairment, and she had difficulty following simple instructions. Based on a totality of the circumstances, the defendant was arrested for DUI. The defendant provided breath samples of .235% BrAC and .250% BrAC. The defendant was positively identified by her Florida DL.
