(2022) AT (601 N FLAMINGO RD), THE ABOVE NAMED DEFENDANT COMMITTED THE ABOVE OFFENSES CHARGED AND THE FACTS SHOWING PROBABLE CAUSE TO BELIEVE THE SAME ARE AS FOLLOWS

The def and the victim are married, reside together at the same address and share an infant child in common. On today's date both the victim and def were involved in a verbal altercation in the elevator at 601 N Flamingo Rd (Memorial Hospital West) according to the victim, he advised the def struck him intentionally against his will

The def who was read her Miranda Rights via a department issued text stated that she intentionally pushed the victim in his shoulder area due to him yelling profanities at her while in the elevator. The def denied striking him in his lip area and stated that she believes he attempted to bite her middle finger after she presented it to him during the argument however no marks were visible on the def's fingers.

The victim does not wish to prosecute and refused to provided a sworn statement or any photographs. The victim denied any treatment on scene. This incident was brought to officer's attention when Memorial West Security observed the def crying. No witnesses observed this incident and CCTV from the elevator is not available.
