The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did

The defendant was driving a silver 2018 Mitsubishi SUV bearing a TN license plate of A819UT. She was traveling north on S Howard Ave near Platt St and unable to maintain a single lane, striking the curb very hard. This caused the vehicle to go up onto the curb, shaking the vehicle back and forth. A traffic stop was made and upon making contact with the defendant she displayed multiple indicators of impairment, to include; watery and bloodshot eyes, slurred speech, a strong odor of an alcoholic beverage, slow and sluggish reactions, unsteady stance, an admission to consuming alcohol (three or four drinks), and an admission to coming from multiple bars. The defendant performed very poorly on SFSEs, and multiple clues of impairment were observed. The defendant was arrested for DUI and later submitted to a breath test which had a BrAC result of .218 and .202.

The defendant was identified by her TN DL.
