The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 On 12/4/21, at approximately 0103 hours, Deputy Trujillo (258678) observed a silver Ford F-250 bearing FL tag AXPP24, at a complete stop at the intersection of Montague St and W Linebaugh Ave. Deputy Trujillo observed the traffic control signal to be a solid red for traffic in the turning lane, and observed the vehicle make the northbound turn while the traffic control signal was still red. Deputy Trujillo conducted a traffic stop on the Ford F-250 and observed the defendant in the driver seat of the vehicle. Upon making contact with the defendant, the affiant observed him to have bloodshot droopy glassy eyes, slow slurred speech, and the distinct odor of an alcoholic beverage was emanating from his breath. The defendant was asked to perform Standardized Field Sobriety Exercises which he agreed. During the exercises, the defendant showed signs of impairment and was placed under arrest for DUI. Implied consent was read and the defendant refused to provide two lawful samples of his breath. The defendant was positively identified via his FL DL.
