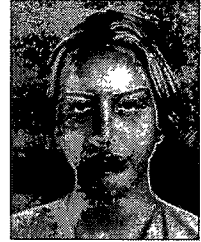

On the above listed date, time and location, Deputy Kirby CCN 7895 conducted a traffic stop on a 2021 Black BMW bearing FL tag # QDGT30 in the 2200 block of SW 10th St. The vehicle is registered to Bobbi Wagner.

When Deputy Kirby got behind the vehicle, he had a clear and unobstructed view into the vehicle from the rear window. Once Deputy Kirby activated his emergency lights and

Probable Cause Affidavit

Before me this date personally appeared ANDERSON, TYLER E. (18477) who being first duly sworn deposes and says that on 6 day of January, (year) 2021 at 2800 SW 10TH ST, DEERFIELD BEACH, FL 33442 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

sirens, he observed the driver of the vehicle making furtive movements all around the vehicle and ultimately jumping into the back seat. The front female passenger then jumped into the driver seat and the original driver jumped into the front passenger seat.

Once the vehicle came to a stop the original driver, who was identified as Sammy Sherood, was immediately detained. It was discovered that Sherood is a habitual traffic offender and was placed under arrest. The female was identified as Bobbi Wagner, the registered owner of the vehicle. After speaking with Wagner, she stated that she knew Sherood did not have a valid license. It was determined that she jumped into the front seat of the vehicle to distract deputy Kirby's attention from the original driver, obstructing the traffic stop. Wagner was placed under arrest.

Due to both occupants being arrested the vehicle was inventoried to be towed. While inventorying the vehicle I discovered lose cannabis scattered throughout the entire vehicle and burnt cannabis rolled in cigar wrappers. Further inventory of the vehicle revealed a clear plastic bag containing 5 white pills labeled as "GG249" which was located in the back seat intermingled in female clothes. Poison control confirmed these pills are alprazolam 2MG. Wagner did not have a prescription for this medication.

Wagner was issued one citation for permitting an unauthorized person to drive (citation # AFDYL7E. She was also arrested for possession of alprazolam, obstruction and possession of cannabis under 20 grams.
