The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did

The defendant was driving a 2015 blue Acura four-door bearing a PA license plate of KRT7499. He was observed stopped for a red light, traveling south on Armenia at Kennedy and his vehicle was over the stop bar and stopped at an angle within his lane. As we waited at the red light, the vehicle rolled forward and further into the intersection. I conducted a plate check and discovered the registration was expired (05/31/2021). A traffic stop was conducted at W Azeele St and S Moody Ave and upon making contact with the defendant he displayed multiple indicators of impairment, to include; watery and bloodshot eyes, droopy eyelids, slurred speech, an odor of an alcoholic beverage, and an admission to consuming alcohol (beer). The defendant performed SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later refused to submit to a breath test despite acknowledgment of the Implied Consent Warning.

The defendant was identified by his FL DL.
