The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

On the above listed date and time, at the above listed location, the victim and defendant were engaged in a verbal altercation which turned physical when the defendant stepped aggressively toward the victim, grabbed her by both arms over her triceps area and began shaking her aggressively while she was on the phone with the defendant's mother. The shaking of her arms caused the phone to slip from the victims hand and ear and the phone subsequently struck her in the upper lip. The victim was able to break away from the defendants grip and separated herself from the defendant. The defendant then tried to retrieve their three year old child from their bedroom in an attempt to take the child with him to his mother's residence, planning to drive. The defendant was highly intoxicated, therefore the victim stood in the doorway to protect her child at which time the defendant once again grabbed the victim by her arms and upper shoulder area and began aggressively shaking her once again. The defendant ultimately shoved the victim backward toward the couch within the living room where the victim was able to brace herself and managed to land on her buttocks in a seated manner ultimately protecting her stomach as she is currently 34 weeks pregnant. The defendant did unlawfully, actually and intentionally strike the victim against her will causing bodily harm and leaving scratch marks on her arm and neck.

The defendant is well aware that the victim is pregnant as he has been to multiple ultrasound and doctors appointments with the victim as he is the father of the child. The victim is clearly and obviously pregnant as she is currently 34 weeks pregnant. The victim and defendant have a mutual child in common who is three years old, are married but currently separated, and have lived as a family unit in the past. The victim and defendant have been in a romantic relationship for a total of six years and have been married for the last year and a half. The victim identified the defendant by his full name and date of birth as the individual who committed the offense. The defendants identity was confirmed via the HCSO database and his DHSMV photograph. The defendant fled the scene prior to law enforcements arrival.
