Probable Cause Affidavit

Before me this date personally appeared STEMEN, DENNIS G. (7610) who being first duly sworn deposes and says that on 25 day of December, (year) 2021 at 1 SEMINOLE WAY, HOLLYWOOD, FL 33314 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

consent.

TO WIT: VICTIM was playing Baccarat in the "High Limit" area of the Hard Rock Casino, when the DEFENDANT approached the table, and sat down two (2) seats away from the VICTIM and started playing. While at the table, the DEFENDANT began flirting with the VICTIM and mentioned they should, "Grab some drinks". VICTIM and DEFENDANT proceeded to the Oculus bar in the hotel and had drinks wherein, the VICTIM started to feel dizzy. VICTIM stated after feeling dizzy the next thing he remembered was waking up in the hotel room and his watch and gaming chips were missing. VICTIM stated he did not remember signing for the room nor walking to the room.

VICTIM stated the following day while going through his phone for clues as to identifying the DEFENDANT he called a number he did not recognize wherein, the DEFENDANT answered the phone. DEFENDANT asked the VICTIM, "Who was calling". VICTIM asked if she remembered him from last night; in which, the DEFENDANT said, "Wrong number" and hung up. VICTIM stated he called several more times (20) and she would not answer the phone. VICIM stated he used "WhatsApp" to make the calls wherein, a picture of the DEFENDANT was displayed with the phone number. The picture from WhatsApp matches the DEFENDANT.

VICTIM met with an SPD Officer to provide the phone number he found for the DEFENDANT. The Officer told the VICTIM, he located the same phone number for her and that he also called the number and did not get a response.

CCTV footage shows the VICTIM and DEFENDANT enter VICTIM's hotel room at 1:23PM.

Probable Cause Affidavit

Before me this date personally appeared STEMEN, DENNIS G. (7610) who being first duly sworn deposes and says that on 25 day of December, (year) 2021 at 1 SEMINOLE WAY, HOLLYWOOD, FL 33314 (crime location)

the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

Sixteen (16) minutes later, DEFENDANT exits the room, and is seen running down the hallway from the room to the elevators. DEFENDANT exits the building leaving the property in a yellow cab.

Hard Rock Security provided a copy of DEFENDANT's Players Club Card information and a copy of her Georgia Driver's License (GDL) she provided when applying for the Player's Club Card.

The information on DEFENDANT's GDL from the Player's Club was provided to Seminole Police Department's Communications Center wherein, DEFENDANT's Driver's License photo and Driver's License information was requested from the State of Georgia's Database through NCIC. The Georgia driver's license photograph and GDL information returned from Georgia matches that of the GDL provided to the Player's Club and CCTV footage photographs of the DEFENDANT.

On January 4, 2022, DETECTIVE CHRISTINA O'SHIELDS showed the VICTIM a photo array consisting of six assorted female photographs. The DEFENDANT's GDL photograph was used in the array. The Victim immediately identified the DEFENDANT from the photo array when shown to him.
