The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did

The defendant was operating a blue 2017 Toyota Prius, 4 door, Florida tag JRLE93. The defendant vehicle was observed stopped beyond the painted white stop line, and blocking the clearly marked pedestrian crosswalk, at a steady red traffic light. After the light cycled to green the defendant proceeded, and approached another vehicle that was backing up across his travel lane, trying to back into a private driveway. The defendant had plenty of time and room to slow, stop, or maneuver around the other vehicle (a white 2004 Toyota Sequoia, 4 door SUV, Florida tag RME422). The defendant did not apply his brakes until the last second before impacting the Toyota SUV. The defendant vehicle front right fender/bumper struck the Toyota SUV's front left fender, causing an estimated \$10,000 in damages to the SUV. The defendant then continued driving approximately 490 feet before coming to a stop. This crash was witnessed by your affiant. The civil crash investigation was completed and a criminal DUI investigation was conducted, which the defendant was informed of. The defendant was read his Miranda Rights. The defendant had a strong and distinct odor of an alcoholic beverage on his breath. The defendant's eyes were bloodshot, glassy, and watery. The defendant's face was flushed and his speech was slurred. The defendant was unsteady exiting the vehicle, and he swayed while standing. The defendant stated that he consumed "2 or 3" IPA beers tonight. The defendant agreed to perform Field Sobriety Exercises. The defendant exhibited signs and clues of impairment, and based on a totality of the circumstances he was arrested for DUI. The defendant provided breath samples of .211% BrAC and .195% BrAC. The defendant was positively identified by his USA Passport.
