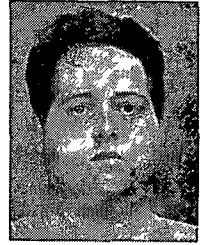

Probable Cause Affidavit

Before me this date personally appeared SMITH, AUSTIN (1015) who being first duly sworn deposes and says that on 7 day of May, (year) 2022 at _____ (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

that the subject was attempting to leave in an older model _____. The notes then said the subject hit another vehicle, and said the tag for the subject's _____ was actually _____. I ran this FL tag through FCIC NCIC while still enroute, and saw it came back to a 2005 silver _____ owned by a white male Brett Menken.

As I arrived I saw a woman, later identified as Longhorn Steakhouse manager _____ standing with a small crowd of approximately 10 people outside of the front door of Longhorn Steakhouse. _____ and the others all yelled at me as I drove up to them, saying "He's leaving right now! Right there!" All parties were pointing at a _____ that was approximately 30 yards away leaving the parking lot. I drove up behind the _____ they were pointing at and saw it bore the same tag that dispatch had provided, _____. I could also see it was a white male driving the vehicle, and he was the sole occupant. I conducted a traffic stop as he was attempting to leave the parking lot.

I approached the vehicle and met with the driver who identified himself as Brett Menken. Menken spoke with slurred speech and rocked left and right slowly as I spoke with him. I asked Menken what had happened inside Longhorn, and he said "They said I could leave." I asked if he had his driver's license on him, and he began to search his pockets. After approximately 30 seconds, he handed me a credit card. I asked if he had a driver's license on him, and he said he did not, but he was "in the system." Menken asked if he could exit the vehicle, and I said he could. As he exited the vehicle, he had to lean on the door for support. He attempted to take a step away from the car and was swaying heavily, so he fell back against the vehicle.

Probable Cause Affidavit

Before me this date personally appeared SMITH, AUSTIN (1015) who being first duly sworn deposes and says that on 7 day of May, (year) 2022 at [REDACTED] (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

Lt. Bradley asked if Menken had any medical conditions, and he said he was diabetic. He said he had taken his diabetes medication 12 hours ago, which was within the proper time between doses. I asked if Menken had had any alcohol this evening, and he said no. I spoke with Longhorn Steakhouse manager [REDACTED] who provided me a copy of Menken's bar tab that he had left without paying. This bar tab had 8 separate alcoholic beverages that Menken had ordered.

I asked if Menken would be willing to submit to Standardized Field Sobriety Tests, and he said no. Lt. Bradley told Menken that the decision to arrest him would be based off of my observations of him up to this point, and asked again if he would participate in SFSTS. Menken refused again. Based on all of the information I had gathered up to that point, I had probable cause to believe that he was under the influence of alcohol to the point that his faculties were impaired. Lt Bradley #726 asked him if he would consent to a breath test. He said no. She read him implied consent from a prepared text and asked him again if he was willing to submit to a breath test and Menken refused again. I transported him to the Davie PD for processing and subsequently to BSO Main Jail without incident.
