

nose and mouth, his eyes were watery/very bloodshot, his face appeared flushed, and his speech was slurred/mumbled/repetitive(see video) At this time I proceeded to speak to Wheel Witness Ricardo Chavez, 11/24/1965, who stated that he observed Brian Bierwirth screaming and verbally abusing his girlfriend and he was told to stop Mr Bierwirth left the scene briefly and came back driving his 2017, White, 4 door, Chevy Silverado Pickup truck, Florida Mr Bierwirth parked his vehicle in the middle of Main Street and proceeded to verbally berate Wheel Witness Yokana Martinez, 01/08/1977, who had earlier told Mr Bierwirth to treat his wife better. While he was screaming at Witness Martinez, Witness Chavez walked over to intervene as the Mr Bierwirth appeared to be getting angrier When Witness Chavez intervened he stated that the Mr Bierwirth charged at him and he pushed him causing him to fall to the ground. A short time after that we arrived on scene Deputy Castillo also interviewed Witness Fabian Portilla, 11/06/1965, who stated that he witnessed the above described incident but due to the Suspect appearing to be intoxicated he moved Mr Bierwirth's vehicle out of the middle of the street, took the keys and gave them to his girlfriend so he would not drive again Upon completion of our investigation I informed the Mr Bierwirth I was now conducting a DUI Investigation and asked him if he would be willing to perform some simple road side sobriety exercises and he agreed Prior to starting the road side exercises I asked him if he had any medical conditions, was using any medications and how much he had to drink He responded no injuries/illnesses and had a lot of trouble recalling how much he had to drink today He finally was able to tell me he believed he had 5-6 shots of vodka but could not tell me where or when he drank them. The following exercises were demonstrated, performed and captured on BSO BWC and Dash Cam.

Standing Balance Exercise Driver was instructed to put his feet together, place his

Horizontal Gaze Nystagmus. The following clues were observed. -Lack of smooth pursuit in both eyes -Distinct and Sustained Nystagmus at maximum deviation in both eyes -Onset of Nystagmus at 45 degrees in both eyes -VGN was observed in both eyes. -Driver had trouble keeping his head still during the test I attempted to explain the instructional stance to Mr Bierwirth for the Walk and Turn Exercise and the driver could not maintain his balance at which time I terminated the road side sobriety exercises for his safety. At this time I informed the Suspect that he was under arrest for DUI, placed him in handcuffs and retrieved the Florida Implied Consent Law.
