the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

unlawfully drive, or was in actual physical control of a motor vehicle, to wit, 2015 gray Acura TL FL Tag# BMYF92, while he was under the influence of an alcoholic beverage or chemical substance to the extent that his normal faculties were impaired

On the above date and time I was running stationary radar in the 3700 block of Coconut Creek Pkwy I observed the aforementioned vehicle approaching at a high rate of speed from the east to the west With my department issued radar activated, I was able to obtain a read out put of 72 m p h where the speed limit was 35 m p h I made a u-turn after the vehicle which was continuing westbound on Coconut Creek Pkwy at a high rate of speed I was able to catch up to the vehicle at the intersection of Coconut Creek Pkwy and Lyons Rd I initiated a traffic stop on the vehicle in the 4900 block of Coconut Creek Pkwy

Upon approaching the vehicle and driver/sole occupant, Brian McGrade, I asked for his license, registration, and proof of insurance McGrade began to search for his license in his wallet and did so in a slow manner. As McGrade was getting his license, I could detect an odor of an alcoholic beverage emitting form within his vehicle McGrade handed me his license and began to sit there. I asked McGrade if he remembered what I asked him for and he said yes and repeated license, registration, and insurance I then asked McGrade if he had the other items McGrade began to search for his registration and insurance card McGrade then handed me his registration but no insurance card I asked McGrade where he was coming from McGrade began to shake his head both yes and no but wasn't audible I asked McGrade again where he was coming from and he stated Diamond Dolls As McGrade began to talk, I observed him to have bloodshot watery eyes with slurred speech. Also as McGrade began to converse with me, I could detect an odor

of an alcoholic beverage emitting from his breath. I asked McGrade if he had anything to drink which he stated he did I asked McGrade how much he had to drink and he stated enough I asked McGrade how much was enough and he said 3-4 I asked McGrade what it was he was drinking and he stated whiskey

I had McGrade step out of his vehicle and to the rear of it While McGrade got out of the vehicle, he was unsteady on his feet and was stumbling walking to the rear of his vehicle Once at the rear of his vehicle, I went over all of McGrade's answers with him I was still able to smell an odor of an alcoholic beverage emitting from his breath I told McGrade I would be conducting a DUI investigation and asked if he would be willing to submit to some roadside exercises which he stated he would I asked McGrade if he had any physical ailments I needed to be aware of or if he takes any medictaions and he stated he did not The roadside exercises were performed as follows

- 1 Horizontal Gaze Nystagmus McGrade had all 6 cues McGrade lacked smooth pursuit in both his left and right eye, distinct and sustained nystagmus at maximum deviation in both his left and right eye, and onset of nystagmus prior to 45 degrees in both his left and right eye
- 2 Walk and Turn McGrade was unable to keep balance while listening to instructions McGrade stated he understood all the instructions McGrade began the exercises and left gaps between his steps, stepped off the line, stopped walking to steady himself, took the improper amount of steps, and did not complete the turn as demonstrated McGrade did not make a turn and take (9) heel to toe steps back after stating he understood and had to be told to do so

- 3 One Leg Stand (Left Leg) McGrade lost balance and was swaying during the exercise McGrade failed to lift his foot back up immediately McGrade did not count out loud and stumbled during the exercise
- 4 Finger to Nose- (LRLRRL) McGrade failed to touch the tip of his finger to his nose multiple times as demonstrated McGrade failed to keep his eyes closed during the exercises and did not perform the exercise as demonstrated McGrade kept his finger pointed out and never touched his nose as demonstrated

During the course of the exercises, McGrade stated that he knew he failed all the exercises he performed and knew he was going to jail I asked McGrade what made him believe that and he stated that he just knew he failed the exercises

Based on the totality of my investigation, I believe that McGrade was in actual physical control of a motor vehicle to the extent that his normal faculties were impaired I then took McGrade into custody I asked McGrade if he would be willing to submit to a lawful test of his breath to determined its alcoholic content which he stated he would I transported McGrade to CCPD for processing

While at CCPD, I began my (20) minute observation of McGrade at 2328 hours I concluded my observation period at 2348 hours with no abnormalties. I issued McGrade a breath test with the following results Sample 1 was taken at 0002 hours with a result of 222 and Sample 2 was taken at 0005 hours with a result of 224 These results are within the 02 agreement A Breath Test Affidavit was completed and signed
