Probable Cause Affidavit

Before me this date personally appeared CHARLES, TIFFANY (1072) who being first duly sworn deposes and says that on 24 day of June, (year) 2022 at (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

intoxicated so she allowed him to stay the night. While he was sleeping, she went through his phone and saw a video of him kissing another woman in front of his Miami home. woke up Stohr and asked him to leave because he was cheating on her. She asked him to leave multiple times, but he refused and called her crazy. Stohr got up from the bed and was walking to the bathroom as if he was not trying to leave. walked toward him and Stohr said, "if you touch me you will regret it," causing her to back up. had a glass of water in her hand and threw the water in his face. Stohr grabbed and turned her around. He was positioned behind her as he put his right arm in front of her neck, pressing her neck towards him. His left arm was behind her head, pushing her head forward. stated "Stohr is trained in Jiu-jitsu and has been doing it for years, so he knows how to choke someone." felt her head was going to "separate from her body" and she could not breathe. moved to the side attempting to get free and Stohr fell on top of her causing her knees to hit the ground. Stohr got on top of her pushing her face into the floor and squeezing her neck to the point she couldn't breathe and thought her neck was going to pop. thought he was going to kill her. He eventually let go and when she could finally talk asked him multiple times to leave again. Stohr began cursing saying, "Bitch, don't touch me" and "this is how you'll die." She told him she was going to call the police. His demeanor completely changed, his complexion turned white, he stopped cursing and left.

I observed bruising and redness to 's knees, left elbow, right cheek, neck, right shoulder. She is having discomfort in her neck and pain when she tries to swallow. Her right thumb is numb and Davie FR (Eng. 61 RUN: 7400) responded to further examine it.
