Probable Cause Affidavit

Before me this date personally appeared CABAUY, JOSEPH (1084) who being first duly sworn deposes and says that on 25 day of December (year) 2021 at (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

demanded to know where and when he bought them. [REDACTED] showed her the receipt and she became further enraged and hit him several times with her hands on his back and shoulders as he was turned around. She then wrapped her right elbow around his neck and jumped on his back briefly before letting him go. [REDACTED] walked away and said Brittani needed to pack her bags and leave and that he was calling police. No scratches or bruises were observed on [REDACTED] though there was some red marking observed on his neck where he claimed to have been wrapped up by Brittani. [REDACTED] said he was in minor pain as a result of the altercation.

Brittani similarly stated she had gotten into an argument with [REDACTED] over contraceptives and that the argument became physical. She claimed she hit him and wrestled him but she does not know if she did or did not wrap her arm around him or his neck.

I took photographs of [REDACTED] neck and took a sworn digital statement. [REDACTED] signed in favor of prosecution. Based on statements made by both parties I determined Brittani was the aggressor. Brittani was taken into custody, taken to Davie Police Department, and subsequently transported to BSO Main Jail.
