Before me this date personally appeared BRIGGS STEVEN (9172) who being first duly sworn deposes and says that on 6 day of December, (year) 2021 at [REDACTED] (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

and neck. [REDACTED] stated that he was in a verbal altercation with his wife Selchan, Brittany, white female, 11/11/1993, over the internet. The altercation turned physical. The Defendant told the victim that she was going to take Xbox back and started to disconnect it. [REDACTED] (V) attempted to stop the defendant from taking the Xbox. The defendant struck the victim in the face and neck with a USB cord. The victim then stated to the defendant he was leaving with their two kids, Jordan Selchan 2/28/2012 and Kimberly Selchan 9/30/2015. The defendant grabbed her daughter Kimberly and attempted to pull her away from [REDACTED]. [REDACTED] managed to leave the apartment to the parking lot with the two kids ([REDACTED] only) and called 911.

This probable cause affidavit is being completed to charge for Selchan, Brittany with Count 1 BATTERY / TOUCH OR STRIKE. Selchan, Brittany intentionally touched Selchan, [REDACTED] against his will.
