The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 The defendant was driving a blue 2017 Nissan 4-door (FL Tag #HVSY07) eastbound on Palm St E with no headlights on, approaching the intersection of 19th St N. The victim was driving northbound on 19th St N, when he entered the intersection and made a westbound turn in front of the defendant. Because the defendant did not have her headlights illuminated, the victim did not see her, and pulled out in front of her. The defendant struck the victim on the front bumper and continued eastbound until the vehicle came to a stop. The responding officers followed the trail of oil and radiator fluid, and located the defendant to be still behind the wheel of her vehicle, just a couple minutes after the crash occurred.

During the traffic crash investigation, the defendant was identified via a FL DL and exhibited several clues of impairment, to include: Watcry/bloodshot eyes, blank/dazed stare, droopy eyelids, slurred speech, an inability to formulate full sentences, was very slow to respond, made slow/deliberate movements, appeared tired/lethargic, had poor balance, poor coordination, was disoriented and confused (didn't know she hit a car - thought she hit a tree next to her), she was wearing 2 paper nightclub wristbands (1 red band, and 1 green band from The Castle in Ybor City), and emitted a distinct odor of an alcoholic beverage from her breath.

The defendant was arrested for DUI following a poor performance on SFSEs, and was transported to booking.
 While at CBT, she was read Implied Consent and refused to provide a breath sample.
