On November 03, 2021 at or about 0040 hours at 2000 McNabb Road which is located within the jurisdictional limits of the City of Pompano, within Broward County and the State of Florida, the above named defendant did commit the violation of Driving Under the Influence of alcoholic beverage (Florida State Statue 316 193) Caileigh Stoops did, then and unlawfully drive, or was in actual physical control of a motor vehicle, to-wit Blue Jaguar bearing Florida tag Y61YJF while she was under the influence of an alcoholic beverage to the extent that her normal faculties were impaired or has a breath-alcohol level of 0 08 or more grams of alcohol per 210 liters of breath

On 11/03/2021, I responded to the area of 2011 N E 68th Street for a vehicle that drove into the water While responded to that location Stoops was located in the parking lot of the gas station in the area of 2000 McNabb Road When I stopped at this location Officer Gustafsson responded to the original location and located Jade Coldren (witness) and the Blue Jaguar partially in the water and partially on the sea wall, see Officer Gustafsson crash report for more information on his involvement

Officer Anna Perez transported Colderon to my location and he identified Stoops as the female that was in the car while it was in the water and there was not anyone else around

While speaking with Stoops she appeared confused/disoriented, her face was red/flush, I could smell the odor of an alcoholic beverage coming from her breath/person, and her behavior was erratic I asked Stoops how her car ended up in the water and she said " I

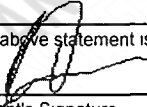
I explained that the crash investigation was complete and that I was conducting a criminal D U I Investigation and Stoops said she understood I attempted to read Stoops her Miranda Warnings but she started hyperventilating and would not pay attention to me I attempted to ask some basic medical question and received the same response I asked if she was willing to submit to a series of field sobriety exercises, which she agreed to perform but continued to cry, hyperventilate, and pretty much ignore me I gave Stoops several minutes to calm down and I explained to her that if she refused to cooperate I would have to base my decision to either arrest or not arrest her based on my observations to this point Stoops again said she would cooperate but her actions said different

Based on my observations Stoops normal faculties are impaired by an alcoholic, controlled or chemical substance Stoops was placed into Custody at 0040 hours I advised Stoops that she was under arrest for driving under the influence of alcohol, and/ or a chemical substance, and or a controlled substance I requested Stoops submit to a breath test to determine the alcohol content of her breath and she agreed I conducted the 20 minute observation and Stoops provided two valid breath samples of 171 and 184

I transported Stoops to the Broward Sheriff's Office Main Jail where she was booked and charged, without incident The vehicle was towed by West Way Towing to West Way Towing's facility
