The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 11/24/2021 at approximately 0330 hours, located at 2618 Irene St, the defendant and the victim were engaged in a verbal argument regarding the victim's three pet dogs who also reside at the above address. The defendant was upset the victim was not taking ample care of the dogs, and subsequently grabbed the victim by the neck forcefully against the victim's will. The victim is elderly (75 years old), and is confined to a bed with the inability to care for herself. The defendant lives with the victim as a caretaker and family member (the defendant being the granddaughter of the victim). The residence above, including the direct room of the victim, was observed to be in unlivable conditions, with excess amounts of animal feces, trash, and broken furniture completely filling the entire living quarters. The defendant has a young child (two years old), who resides at the rear of the residence with the co-defendant and defendant. Law enforcement entered the residence to conduct a welfare check, where the child's living conditions observed matching closely to that of the front of the residence, which are also considered to be unsanitary and not suitable for a child to inhabit. The defendant was identified as the individual who committed the above battery. The defendant was identified via FL DL, and booking photo.
