The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 02/06/2022 at approximately 0240 hours, TPD Ofc. D. Huth conducted a traffic stop on a orange 2012 Honda hatchback with Florida tag RMC321 at the I-275 southbound on-ramp from Hillsborough Av E after it was observed failing to stop at the white stop bar at the red traffic signal at Hillsborough Av E and Cherokee St N (I-275). Ofc. D. Huth observed indicators of impairment and I responded to assist with a DUI investigation. I made contact with the driver/defendant and observed her to have bloodshot and glassy eyes, she had dilated pupils, slurred speech, and I observed the strong odor of an alcoholic beverage coming from the interior of the vehicle. The defendant exited the vehicle and was observed to be unsteady on her feet and I confirmed the odor of an alcoholic beverage was coming from her breath. The defendant participate in SFSTs and I observed additional clues of impairment. The defendant admitted to drinking prior to driving. The defendant was arrested and refused to submit to the requested testing after being read Implied Consent.

The defendant was positively identified via DHSMV photograph.
