 The defendant was stopped as a hit-and-run suspect while operating a motor vehicle on the public roadway. The defendant was observed by the affiant driving the vehicle in actual physical control while driving. The defendant had the odor of an alcoholic beverage emanating from his mouth, was slurring his words, and presented a noticeable sway. The defendant agreed to allow me to check his eyes.
