Art. 1 § 16(b)</p> <p><b>I was dispatched to 6575 Lake Loran Way in unincorporated Lake Worth, Palm Beach County, Florida reference an assault.</b></p> <p><b>Upon arrival I met complainant/victim, Patrick Rodriguez, who was verbally identified. He informed me his neighbor, white male Carl Bohr, came into his driveway and confronted him about a boat located in the backyard. Bohr began cussing at him and stated "The next time your fucking boat is on my grass it will be in the fucking lake." He replied I don't know why you have to come here cussing at me first thing in the morning. Rodriguez walk towards him at which time Bohr drew a firearm and pointed it at him so he then backed up in fear for his life of being assaulted with the firearm. Bohr then walked away towards his residence next door. He described the firearm as black with a bulbous barrel and it was removed from his waistband on the left side.</b></p> <p><b>I made contact with Carl Bohr by phone at which he exited his residence, walked towards me and was detained without incident utilizing PBSO issued handcuffs. He was verbally identified then read his Miranda Rights. He waived his rights then proceeded to inform me off the following while being recorded with my in-car video camera. He stated he did enter Rodriguez's driveway and confront him about the boat. The confrontation was verbal in nature with cussing between the two until Rodriguez was seen balling up his fists so he pulled a gun out of his waistband located on his left side and pointed it at him. He referred to it as a gun but described it as pepper spray. It should be noted a gun holster was discovered in the waistband of his right side with no gun in it, only a loaded magazine. After the event he walked back home. He said the gun shaped pepper spray and gun were inside his home.</b></p> <p><b>I recovered the pepper spray which was black with a large diameter barrel and on the handle it had the words MACE printed. I presented it to Rodriguez which he positively identified as the item pointed at him. The event was witnessed by landscapers on the property at the time. Jorge Eluir confirmed the above stated events occurred but he could not identify the item point at Rodriguez.</b></p> <p><b>Based on the aforementioned facts I find probable cause exists for the arrest of Carl Bohr for Assault when he did intentionally and unlawfully threaten by word or act to do violence to the person of Patrick Rodriguez, coupled with an apparent ability to do so, and did point a gun shaped object, which created a well-founded fear in Patrick Rodriguez that such violence was imminent, contrary to Florida Statute 784.011.</b></p>
