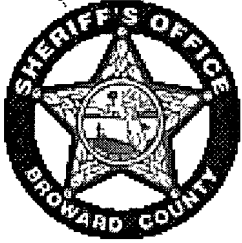
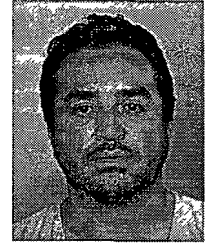

The above listed defendant (Carlos Pemberty) was involved in an argument with his live in wife ([REDACTED]) during the course of the argument Carlos pulled his wife's hair (grasping on her right back side of her head) [REDACTED] stated that Carlos did this after tearing a family picture and being angry about her not buying food for him Post Miranda, Carlos denied pulling his wife's hair and stated that she struck him in the face and he did not retaliate Carlos wife was also arrested as the primary aggressor could not be determined There were no visible injuries to either party and no independent witnesses to the fight Both parties refused to prosecute
