The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

On 5/16/22, at approximately 0338 hours, the Affiant observed a 2017 Black Maserati Ghibli bearing FI tag B0JGR and VIN ZAM57XSA0H1196510 traveling north on Dale Mabry Hwy. The Black Maserati was travelling down the roadway with none of its lights activated. The affiant conducted a traffic stop on the aforementioned vehicle at Dale Mabry Hwy / Fletcher Av E, Greater Carrollwood, FL 33618 and observed the defendant operating the vehicle. Affiant detected signs of impairment and requested the defendant perform field sobriety exercises. The defendant agreed to perform the field sobriety exercises and continued to show multiple signs of impairment. After a proper 20 minute observation, the defendant provided a lawful sample of breath of .141/.137 BrAC. The defendant was identified via FL DL.
