While I was driving westbound in the 5400 block of Okeechobee Blvd I observed a white in color 2015 Mazda CX-5 bearing FL tag # GTNQ60 pass me at a high rate of speed. Upon catching up to the vehicle I paced the Mazda driving at approximately 65mph in a 45mph zone. After pacing the vehicle I completed a traffic stop on the vehicle. I approached the passenger side of the vehicle and made contact with the driver who was identified as Carolina Santos (registered owner of the vehicle). [REDACTED] through FCIC. Santos was then told the reason for the stop to which she advised she was speeding because she wanted to get home due to her having a rough day. I asked Santos for her driver's license, registration and insurance card. Upon asking Santos for documents she began to rummage through the vehicle for the items missing them several times. I asked Santos two more times for her documents which she failed to provide. Upon Santos failing to provide me with the documents I asked her to shut off and exit the vehicle. While Santos was exiting the vehicle I observed her brown eyes to be red and glassy. While Santos was standing on the sidewalk she advised D/S Benson that she had consumed an unknown size glass of wine.</p> <p>Due to the suspicion of Santos operating a motor vehicle underneath the influence of alcohol a DUI investigator Ward was called and arrived to the scene. DUI investigator Ward completed a DUI investigation and found probable cause to arrest Santos.</p>



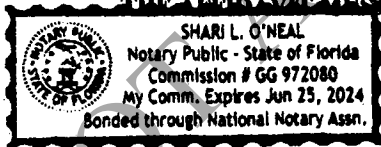



The defendant was instructed to await the completion of the instructions prior to beginning the task. The defendant acknowledged that they clearly understood my instructions. I then instructed the defendant on the task. The defendant stated that they clearly understood my instructions for the task. I placed my stimulus in front of the defendant and ask the defendant if they could see it to which he said "yes." I asked the defendant what color the stimulus was to which they answered. "Silver." Upon commencing the task the defendant moved their anticipated the stimulus, and/or did not follow the stimulus as instructed. I had to re instruct the defendant multiple times during the task to follow the stimulus with their eyes only. During the task, I observed that the defendant had equal pupil size and did not exhibit resting nystagmus. The defendant's eyes tracked equally.</p> <p>I then checked the defendant for Vertical Gaze Nystagmus (VGN). I did not see a distinct and sustained nystagmus at maximum deviation in both of the defendant's left and right eyes.</p> <p>An inventory of the vehicle was conducted prior to tow and found three empty bottles of Meiomi wine (37s ml) bottles. The vehicle was towed form the scene by Tows R Us towing to their lot.</p>

PERSONAL CONTACT

DRIVING PATTERN: Actual physical control (physical evidence or statements putting def. behind wheel of vehicle)

I was called to the scene of a traffic stop near the intersection of Okeechobee Blvd and Vista Parkways, in unincorporated West Palm Beach, Palm Beach County, Florida. I arrived at the scene at approximately 0221 hrs.

D/S S. Kenny # 39602 told me, in a signed sworn PC Supplement, that he had stopped the defendant's vehicle, white mazada bearing FL tag GTNQ60 because the defendant's vehicle was traveling at an unlawful speed (65 mph in a 45 mph zone). D/S Kenny noticed that the defendant had articulable indicators of impairment, so he requested me to respond to conduct a possible DUI investigation. D/S Kenny identified the defendant, to me, as the driver / sole occupant of the defendant's vehicle, at the time of the stop (See supplemental PC for further).

OBSERVATION OF DRIVER:

I made contact with the defendant, later identified by using the Driver and Vehicle Information Database as, Carolina Santos. I observed that the defendant had red, watery, bloodshot eyes. The defendant had slurred speech, and the odor of an unknown alcoholic beverage, based on my training and life experiences, that came from their breath which intensified as they spoke to me. The defendant swayed while standing. The defendant stated that she had ADHD but no other medical conditions. She stated that she takes Adderall for her ADHD. She stated that she did not take any illegal drugs for smoke any Marijuana. She stated that she had one large full wine glass of red wine.

I asked the defendant to perform voluntary field sobriety tasks. The defendant consented.

DRIVER'S STATEMENTS:

The defendant stated that she had ADHD but no other medical conditions. She stated that she takes Adderall for her ADHD. She stated that she did not take any illegal drugs for smoke any Marijuana. She stated that she had one large full wine glass of red wine.

ODORS:

I could smell the odor of an unknown alcoholic beverage, based on my training and life experiences, which came from the defendants breath and intensified as they spoke with me.

GENERAL OBSERVATIONS

SPEECH: Slurred

ATTITUDE: Calm, Scared, crying, upset, defiant

CLOTHING: Green Long Sleeve Shirt, Blue Jeans, Sandals

MEDICAL/OTHER: The defendant stated that they had no medical issues. They stated that they had not taken any prescription drugs, any illegal drugs, or smoked any marijuana.

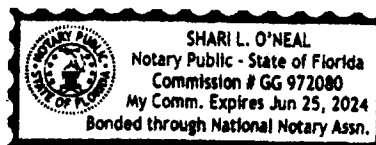

WALK & TURN:

I placed, with the assistance of another deputy, an approximately 2" wide piece of yellow on the ground. I asked the defendant if they knew their left from their right. She originally was sarcastic and stated that she did not. When I asked her a second time she stated that she did while showing me the corresponding feet. I asked the defendant what color the line was and they stated yellow. I had the defendant place their left foot on the line with their right foot in front of the left, heel to toe. I instructed the defendant to remain in the position throughout my instructions and demonstration. The defendant was instructed not to start the task prior to me telling them to begin. The defendant acknowledged and stated they completely understood my instructions. The defendant was then instructed on the task which I also demonstrated. The defendant swayed during my instructions. The defendant came out of the stance prior to me telling them to begin. Once the defendant was told to begin the task they missed heel to toe, stepped off the line, used their arms for balance, made an improper turn, and slowed to balance/steady them self. The defendant swayed throughout completing the task.

ONE LEG STAND:

The defendant was instructed to stand with their feet together and their hands down by their side. They were then instructed to remain in the position throughout the instructions and demonstration until instructed to begin. The defendant acknowledged and stated that they clearly understood the instructions. The defendant swayed while in the instructional position. After being told to begin the defendant put their foot down prior to being told to stop, used their arms for balance, and swayed. The defendant started counting in the manner instructed and then stopped part way through the task.

FINGER TO NOSE:

The defendant was instructed to stand with their feet together and their hands down by their side. The defendant was then instructed to remain in the position throughout the instructions and demonstration until instructed to begin. The defendant acknowledged and stated that they clearly understood these instructions. The defendant swayed while in the instructional position. The defendant mimicked me by tilting their head back prior to being told to start. I instructed the defendant on the task and demonstrated the task. The defendant acknowledged the instructions stating that they clearly understood them. The defendant proceeded to miss/search for the tip of their nose with the tip of their finger, and did not bring their hand immediately bring back as instructed after numerous reminders to do so. The defendant did not keep their head tilted back during the task. The defendant swayed throughout the task.

ROMBERG ALPHABET:

The defendant was instructed to stand with their feet together and their hands down by their side. The defendant was then instructed to remain in the position throughout the instructions and demonstration until instructed to begin. The defendant acknowledged and stated that they clearly understood these instructions. The defendant swayed while in the instructional position. The defendant stated that they knew their English alphabet from A to Z. I instructed the defendant on the task and then demonstrated the task. The defendant acknowledged the instructions stating that they clearly understood them. The defendant then proceeded to misstate their alphabet. The defendant did not keep their head tilted back and/or opened their eyes during the task.

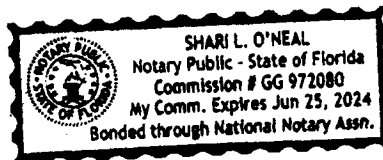

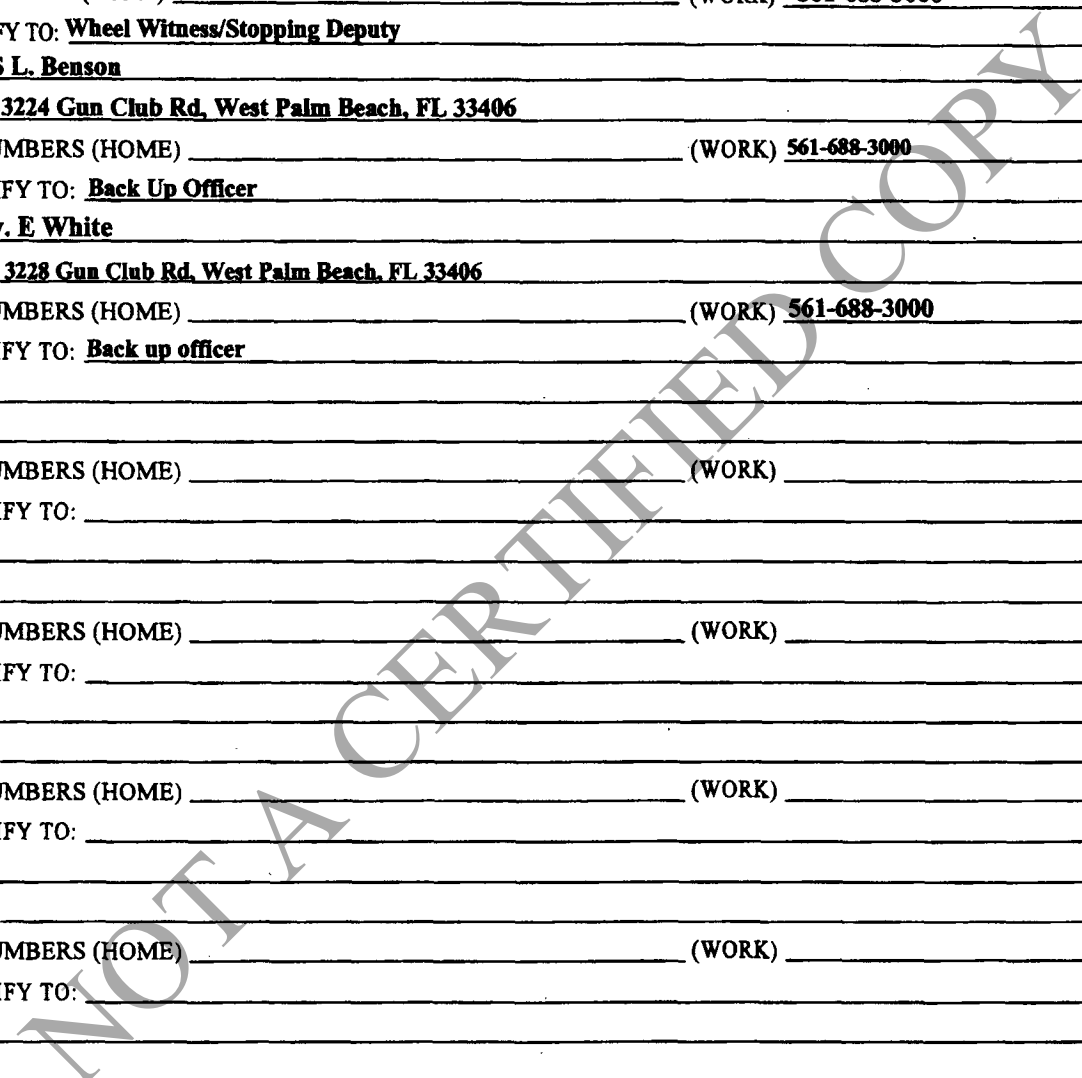
