The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 7/19/2022, at approximately 1313 hours, the defendant and victim engaged in a verbal argument over the defendant remaining at the victim's residence. The defendant was requested to leave multiple times by the victim but refused to do so. During the verbal argument, the victim attempted to place the defendant's phone outside of the residence to assist the defendant in leaving the property. Once the victim reach the front door, and with back turned, the defendant struck the victim on the right side of head utilizing an additional cell phone on her person. The strike caused a visible contusion on the victim's head. The victim and defendant have [REDACTED]. The victim positively identified the defendant as the person who committed the offense. The defendant was positively identified via FL DL.
