On the **17** day of **September**, **2022** at **03:56** (Specifically include facts constituting cause for arrest.)

On September 17, 2022, at 01:57 a.m. I was dispatched to 2582 PGA Blvd, Palm Beach Gardens, Florida 33410, Palm Beach County (parking lot in front of CR Chicks) in reference to a disturbance. My body worn camera was used during my investigation.

Upon arrival I made contact with Catherine Vanwanderham (identified by her Florida issued driver license) who advised she had a verbal argument with _____ (identified by his Florida issued driver license), in the parking lot. She stated that the argument was verbal and never became physical. She advised she was mad at _____ for leaving the Snuggery with his friends and not her. She stated that she grabbed ahold of the vehicle window area when it was attempting to leave, and she was dragged by the vehicle before falling to the ground. Vanwanderham advised she did not want Palm Beach Gardens Fire rescue to check her out. Vanwanderham had scrapes on her arms and ankles that were not bleeding when she showed them to me.

I made contact with Brandon Mangan (identified by his Florida issued driver license) in the parking lot who provided the following sworn statement: Mangan advised he was in the parking lot and he saw Vanwanderham approach _____ near a vehicle and begin to argue with him. Mangan stated that he saw Vanwanderham slapping _____. He advised _____ never attempted to fight back with Vanwanderham. He advised he saw _____ get in the passenger side of a vehicle and Vanwanderham pursue him. He advised that Vanwanderham was attempting to strike _____ while he was in the vehicle so the vehicle began to drive away. Mangan stated that Vanwanderham grabbed ahold of the vehicle as it was driving away and that caused her to go to the ground.

I contacted _____ at a phone number provided by Vanwanderham because he was not on scene when I arrived. He advised that he was attempting to leave the Snuggery with some friends because he was ready to leave and Vanwanderham was not ready to leave. He stated that Vanwanderham texted him when he was still in the parking lot saying that there



were guys in the Snuggery that wanted to beat him up. [REDACTED] advised Vanwanderham approached him alone in the parking lot shortly after receiving the text from her. He stated that she began to yell at him, and they were arguing. [REDACTED] advised that Vanwanderham hit him a couple times and then he got in the passenger side of his friends' vehicle. He advised that as they tried to drive away, Vanwanderham grabbed ahold of the window area of the vehicle and the vehicles forward momentum caused her to go to the ground. [REDACTED] advised he has [REDACTED] Vanwanderham [REDACTED]

I asked [REDACTED] to return to the scene so I could get his statement on body worn camera and he agreed to return. When I attempted to swear in [REDACTED], he saw Vanwanderham in hand cuffs and he became uncooperative. He stated that he did not care if she hit him, she does not want her to go to jail. When he was making this statement, he lifted the right sleeve of his shirt and there was a visible bruise. I gave [REDACTED] a Victim Rights Brochure, but he refused to sign the receipt for receiving it.

Due to the above listed facts I find probable cause to arrest Catherine Vanwanderham for Domestic Battery (Dating Violence) per Florida State Statute 784.03(1)(A)(1).
