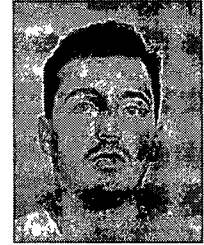

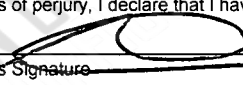

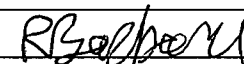

Before me this date personally appeared POPICK, SCOTT (11307) who being first duly sworn deposes and says that on 2 day of December, (year) 2021 at (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

Powell sustained pain to her legs and was transported by Oakland Park Fire Rescue to Holy Cross Hospital for treatment (Run #8673) and responded to the scene and conducted the traffic crash investigation Both vehicles sustained extensive damage

During the course of the investigation, observed the following signs of impairment about Valerio glassy eyes, unsteady on his feet as he rocked back and forth while trying to stand still, slurred speech, and an odor of alcoholic beverages emanating from his breath during conversation Valerio stated after he crashed, he parked at the Shell Station on the corner and walked back to check on Powell Valerio had 2 Corona beers (one half way consumed and the other full and closed) in his hands Valerio stated only 1 of the beers was his, but he drank 1 beer earlier There were no passengers in either vehicle Air bags in both vehicles deployed. I was contacted at 0354 hours to respond and conduct a DUI investigation

I arrived on scene at 0404 hours and was informed of the aforementioned by Deputy Tapia I contacted Valerio, who was seated on the pavement I introduced myself and learned he primarily speaks Portuguese and Spanish, but understands some English, as he's been living and working in the US for the past 2 years as a barber assisted with translation I observed signs of impairment including glassy and bloodshot eyes, slurred speech, and an odor of alcoholic beverages emanating from his breath during conversation I informed him the crash investigation was completed and I was initiating a DUI investigation I requested he walk to the front of my patrol vehicle, which was equipped with additional lighting and a dash camera He stated he was not injured in the crash He stated he was not diabetic, was not taking any medication, did not have any

Before me this date personally appeared POPICK, SCOTT (11307) who being first duly sworn deposes and says that on 2 day of December, (year) 2021 at [REDACTED] (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

injuries, illnesses, or balance issues, and was feeling healthy, and would submit to the roadside sobriety exercises I asked him to perform Valerio was unsteady on his feet, as he rocked and swayed while standing in front of me The following exercises were individually explained and demonstrated prior to the start of each exercise The exercises were conducted and performed in the street, with overhead lighting, next to the crash scene

Horizontal Gaze Nystagmus (6 / 6) Valerio followed the stimulus with his head and had to be reminded to keep his head still He swayed during the exercise He had equal tracking, equal pupil size, and no resting Nystagmus in both eyes He displayed a lack of smooth pursuit in both eyes, a distinct and sustained Nystagmus at maximum deviation, and an onset of Nystagmus prior to 45 degrees in both eyes There was no Nystagmus observed during the Vertical Nystagmus check

Walk and Turn (5 / 8) Valerio failed to keep balance while listening to the instructions He walked forward 10 steps, swaying his body side to side He turned around and took 9 steps back, even as he counted to 10, as he missed saying 7 He used his arms for balance on the return walk and stopped to steady himself as he walked

One Leg Stand (3 / 4) Valerio began prior to being instructed to begin, as he bent his knee while standing on one leg. He was advised to wait until the end of the instructions to begin He swayed and used his arms for balance, extending his arms outward He also extended his leg outward and to the side He hopped about, and did not count aloud

I placed Valerio under arrest at 0438 hours and requested a breath test, to which he replied he would I conducted the 20 minute observation. Valerio provided valid breath test samples of 171 and 177 at 0501 hours and 0504 hours, respectively I read Valerio his Miranda Warnings, per BSO issued card, with repeating them in Spanish, and he stated he understood and would answer questions Valerio stated he was driving home from the beach and had 2 beers today, believed he was not impaired, but stated he didn't think he should have driven Digital pictures of the scene were taken and uploaded to Evidence com completed a DUI Supplemental Report. A Teletype / DAVID check revealed Valerio had a suspended FLDL, which expired on 05/24/2020 Valerio was transported to the Oakland Park District Office for paperwork completion and then to the BSO Main Jail for further detention BWC and Patrol Vehicle Dash Cam
