The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did  
 On 02/08/2022 at approximately 0014 hours, a traffic stop was attempted on a black Mazda SUV with Florida tag IQWE89 at the intersection of Neptune St W and Dale Mabry Hwy N after the vehicle was observed traveling southbound on Dale Mabry at approximately 69 MPH in a posted 40 MPH zone as confirmed by properly calibrated RADAR unit. After I activated my lights to indicate a traffic stop was being conducted, the vehicle continued for several blocks until it pulled into the driveway of the defendant's residence. The defendant ignored verbal commands to stay in his vehicle and contact was made outside of his vehicle. I observed the defendant to have glassy/bloodshot eyes, he had a noticeable sway as he stood, had slurred speech, and had the odor of an alcoholic beverage coming from his breath. While speaking with the defendant outside of his vehicle he attempted to enter into his residence and was physical stopped. The defendant declined to participate in a DUI investigation and was arrested.

The defendant provided a breath sample which produced a BAC of 0.125/0.116. The defendant was positively identified via DHSMV photograph.
