The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

The defendant was operating a gray 2015 Jeep Patriot, 4 door SUV, Florida tag BWPU93. The defendant was stopped for driving at night without having the vehicle head lights on, and unlawful speed as she drove at speeds above 50 MPH in a properly posted 35 MPH speed limit (visually estimated and patrol car paced, TPD DUI unit 5055). The defendant also made a wide right turn, and drifted in the lane so that the left and right side tires crossed onto and over painted lane lines. A traffic stop was conducted. The defendant stopped in the roadway rather than in two different parking lots that was easily accessible. The defendant had a dazed look about her face. The defendant had a distinct odor of an alcoholic beverage coming from her breath. The defendant's eyes were bloodshot and watery, her face was flushed, and her lipstick was smeared. The defendant was forgetful and easily distracted as she had to be reminded to look for certain documents that had been previously requested. The defendant fumbled with documents, displaying poor dexterity. The defendant stated she drank two alcoholic beverages (one shot and one cocktail). The defendant was mildly unsteady exiting the vehicle, her gait was moderately unsteady upon exiting, and she swayed while standing. The defendant agreed to perform Field Sobriety Exercises. The defendant exhibited signs and clues of impairment, and based on a totality of the circumstances she was arrested for DUI. The defendant provided breath samples of .180% BrAC and .181% BrAC. The defendant was positively identified by her Florida DL.
