On the 20 day of July, 2022 at 22:45 (Specifically include facts constituting cause for arrest.)

On July 20, 2022 at approximately 2034 hours, I was dispatched to 757 US Highway 1 Room 155, North Palm Beach, FL 33408 (Super 8 Motel), in reference to a Domestic Battery.

On arrival, I spoke with Chloe E Judge (w/f 02/21/2000), who stated that her boyfriend Anthony F Capone (w/m 02/29/1980), who said they have been dating for the past 7 months, has been drinking and tried to grab the alcohol bottle from her and when she refused, she stated that she tried to take a shower and Capone started banging on the door. Judge said when he got to her, he grabbed her hair and then started punching her in the face, in which her injuries were not consistent with her statement. Judge said she then locked herself in the bathroom and called the police.

I then spoke with Capone, who said they both have been drinking and he tried to take the alcohol bottle from Judge, she began to swing at him causing a small cut on his right cheek.

Please see Police Sergeant Ciezak's supplement regarding a witness verbal statement.

Based on my investigation and the totality of the circumstances, I find Chloe E Judge in violation of F.S 784.03(1). The offense of battery occurs when a person actually and intentionally touches or strikes another person against the will of the other.

Judge was placed under arrest and secured in handcuffs. The handcuffs were double locked and checked for proper fit. Judge was thoroughly searched by Police Officer Wilkinson before being placed in my marked patrol vehicle. At the time of arrest Judge was wearing a brown top, blue jean shorts, and black flip flops.

Due to both party's claiming injuries, there were pictures taken of both parties, which were forwarded over to North Palm Beach Records.

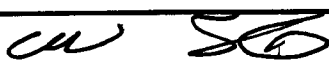
