The defendant was driving a white 2015 Mercedes four door bearing a Florida license plate of M3300W. She was traveling east on Horatio, attempting to continue east across MacDill, and caused a traffic crash when she failed to observe the victims vehicle traveling north on MacDill. The victim's vehicle had the right of way and struck the defendants vehicle causing property damage. The defendant was identified as the driver at the time of the crash. Upon making contact with the defendant she displayed multiple indicators of impairment, to include; watery and bloodshot eyes, slurred speech, an odor of an alcoholic beverage, unsteady stance, and an admission to consuming alcohol. The defendant performed SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later refused to submit to a breath test, despite acknowledgment of the Implied Consent Warning.

The defendant was identified by her FL DL.
