<p>The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:</p> <p>On the above listed date and time, at the above listed location, both the victim and defendant engaged in a verbal altercation that turned physical when the defendant struck the victim on the right side of his head while he was lying on the couch. The victim abruptly stood up from the couch after being struck in the right side of the head and caused the defendant to stumble backwards and fall. The victim attempted to exit the residence and while walking toward the doorway was further physically battered when the defendant grabbed the victim by his hair and pulled him to the ground. Both the victim and the defendant fell to the ground within the kitchen of the residence.
