The following incident occurred in the City of Delray Beach, Palm Beach County, FL:
 On Saturday May 14, 2022, at approximately 0102 hours, I responded to [REDACTED] in reference to a disturbance. Upon arrival I made contact with the complainant [REDACTED] who provided me with the following sworn statement: She had some friends over and they were all hanging out in the back patio of her residence but she became tired and went to bed and left the group of friends on the patio. She was inside of her residence in her upstairs bedroom sleeping when she was awakened by a commotion. She woke up and observed her ex-boyfriend, W/M Christopher O`Reilly, inside of her bedroom in a tussle with one of her friends, [REDACTED]. After tussling with [REDACTED], O`Reilly quickly left the room and ran downstairs and exited the residence leaving through the rear gate on the east side of the residence. [REDACTED] and O`Reilly used to be in a romantic relationship, however, she broke up with him approximately a year ago.

[REDACTED] is in the process of obtaining a restraining order against O`Reilly because he has been calling her nonstop and has been randomly coming by her residence. It should be noted that there is an active criminal trespass warning against O`Reilly at the residence (DBPD Case # 21-11895) [REDACTED] issued a trespass warning against O`Reilly because of the unwanted and unsolicited visits to her residence. It should be noted that O`Reilly called [REDACTED] repeatedly while officers were on scene investigating this incident. [REDACTED] was shown a familiarization of O`Reilly and she recognized him as the person who she observed tussling with [REDACTED] inside of her bedroom inside of her residence. [REDACTED] did not give O`Reilly permission to enter her residence. [REDACTED] she wished to pursue charges against O`Reilly for entering her residence without her permission.

I made contact with Victim #2, [REDACTED], and he provided me with the following sworn statement: he is good friends [REDACTED], and he was at her residence tonight hanging




out in the back patio along with his sister [REDACTED], friend [REDACTED] and friend [REDACTED]. He did not know O`Reilly other than the stories that [REDACTED] told him about their relationship. While [REDACTED] was sitting in the back patio, he observed a white male, later identified as O`Reilly, enter the back patio through a gate. O`Reilly stopped momentarily and said something to the group of friends then proceeded to enter the residence through an unlocked side door of the residence. [REDACTED] became suspicious that O`Reilly was the person that [REDACTED] used to talk about, so he ran inside of the residence behind O`Reilly. O`Reilly ran upstairs directly to [REDACTED]'s bedroom where he was confronted by [REDACTED]. [REDACTED] grabbed a hold of O`Reilly's arm and told him to leave. O`Reilly then forcefully shoved [REDACTED] in the chest area with both of his hands. [REDACTED] then pushed O`Reilly back. After being battered by [REDACTED], O`Reilly ran downstairs and left the area in his silver GMC Sierra vehicle. [REDACTED] did wish to press charges against O`Reilly.

I made contact with Witness #2, [REDACTED] and she provided me with the following sworn statement: she is friends with [REDACTED], and she was hanging out at [REDACTED]'s residence with the above-mentioned group of friends. All of the sudden one of [REDACTED]'s dog begin to bark and then O`Reilly entered the property through a gate in the back patio. After saying something to the group of friends, O`Reilly entered the residence ran upstairs towards [REDACTED]'s bedroom. Thrower recognized O`Reilly because she had met him earlier. Thrower was shown a familiarization photo of O`Reilly and she recognized him as the person who entered the gate through the back patio and entered the residence.

I made contact with Witness #3, [REDACTED] and she provided me with the following sworn statement: she is friends with [REDACTED], and she was hanging out at [REDACTED]'s residence with her brother, [REDACTED], and a group of friends. [REDACTED] heard one of [REDACTED]'s dog began to bark and, shortly after, saw a white male subject enter the back patio through a side gate. [REDACTED] did not know who the male subject was but she was aware that [REDACTED] was having problems with an ex-boyfriend. [REDACTED] described the male subject as well built, approximately 32-33 years of age, approximately 6 ft and 2 inches in height, and approximately 200-230 lbs. in weight. The subject looked at [REDACTED] and stated, "how you doing" and entered the residence. [REDACTED] told her brother, [REDACTED], to go after the subject as she suspected the subject to be [REDACTED]'s ex-boyfriend. After [REDACTED] encountered the subject upstairs inside of [REDACTED]'s bedroom inside of the residence, the subject ran downstairs and exited the residence. The subject then got into a silver GMC Truck and left the area at a high rate of speed.

Officers were unable to administer a photo line-up to [REDACTED] and [REDACTED] because O`Reilly did not have a FL DL and there were no available photos of him. However, there were surveillance cameras affixed on the exterior and interior of the residence that captured O`Reilly entering the back patio as well when he entered inside of the residence. I attempted to make contact with O`Reilly, however, my attempts yielded no responses. Crime scene responded to the scene and processed.
