<p>The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant was stopped by TPD Officer C. Taylor while driving a black Land Rover (FL Tag 618YF) for traveling the wrong way, northbound on the southbound lane, of S. Armenia Avenue. During contact, Officer Taylor observed multiple clues of impairment, to included, bloodshot/glassy eyes, slurred speech, and the distinct odor of alcoholic beverages emanating from his breath. Your affiant responded as a DUI investigator and observed the same clues. During SFSEs, the defendant displayed additional clues of impairment, and based on the totality of the circumstances, was arrested for DUI.
