<p>The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 02/26/2022 at approximately 2355hrs, Affiant conducted a boat stop on a 21' white Maverick bearing FL7892NF / Hin: MVIPN144D606 for the purpose of a safety inspection. Upon stopping the boat, affiant made contact with the defendant/operator, who was sitting behind the steering wheel of the boat. During personal contact with the defendant, Affiant observed him to have blood shot watery eyes and detected a strong odor of an alcoholic beverage coming from his breath as he spoke. Based on this, affiant requested the defendant perform seated standardized field sobriety tasks to determine if he was operating a boat while under the influence of an alcoholic beverage and/or controlled/illegal substance. The defendant agreed to the SFSTs. Based on observation of impairment, affiant arrested the defendant for boating under the influence (0016hrs). The defendant was advised Florida Implied Consent (0044hrs), defendant stated he understood and refused to provide a breath sample. The defendant was booked into the Orient Road Jail without incident. The defendant verbally identified himself and produced a Florida drivers license.</p>
