Probable Cause

On July 3rd, 2022, at approximately 1340 hours, I, Officer Lonnie Brevik of the Florida fish and Wildlife Conservation commission (FWC) was conducting state land patrol in the area of Loxahatchee, in Palm Beach County. I was sitting in my marked FWC patrol vehicle on the side of Seminole Pratt Whitney Road. I was on the north end of the road next to J.W. Corbett Wildlife Management Area (WMA). I observed dark colored Audi car, pass me going north on Seminole Pratt Whitney Road. I visually observed the vehicle to be driving approximately 50mph on a dirt road in a construction zone. I observed the vehicle heading towards a disabled vehicle in the road and towards people. As the vehicle approached the people it caused them to get out of the way. The vehicle hit a bump in the road and got stuck in the dirt.

I drove up to the vehicle and activated my emergency blue lights on my marked FWC patrol vehicle initiating a traffic stop reference driving to fast for conditions. FWC Officer Merizio was also on scene. We approached the vehicle as the tires were still spinning in the mud but the vehicle was not moving. Both officers identified ourselves as law enforcement and began to talk to the driver and only occupant of the vehicle. I was able to identify the driver by valid DL#H255166752740 to be Christopher Robert Hickman. I identified the vehicle by expired FL registration 04BBHZ.

Officer Merizio asked the subject for his FL DL. He was able to provide it. I approached the driver and asked him for his registration, and he was unable to provide it. I asked the subject where he going to, and he said home. I asked him where he lived, and he said lake worth. He was not headed in the direction of Lake Worth. I observed an open container of alcohol in the center console of the vehicle. I observed Hickmans eyes to be bloodshot, glassy and droopy. I observed his speech to be confusing and slurred. I detected a strong odor of an unknown alcoholic beverage emitting from his breath as he spoke to me. I observed him to fumble through his wallet. I observed his attitude to be confused and to have mood changes. I observed him to have a red flushed face.

I asked Hickman if he could step out of the vehicle to perform voluntary standardized field sobriety tasks. He agreed. As he got out of the car, I observed him have trouble standing and bracing himself against the car. I told him to walk behind his vehicle and observed him stumbling. At one point I observed Hickman almost fall over. Due to the dirt road not being even I conducted Standardized Seated Field Sobriety Tasks.

Subject stated that he understood all instructions given to him. I had to repeat instructions multiple times. Subject was unable to follow simple instructions.

Based on the vehicle in motion, contact with the driver, standardized field sobriety tasks, interview of the driver and the totality of the circumstances, I placed Hickman under arrest for driving under the influence. I placed Hickman in handcuffs and gave him a lawful order to sit down.

I transported Hickman to the main Palm Beach County Jail. While driving to the jail, Hickman stated that he likes to drink but he is a good guy. He also stated that he knows he deserves this. PBSO operated the Intoxilizer 8000. I read implied consent. Hickman provided two breath samples. Sample 1 contained 0.195 g/210L of breath. Sample 2 contained 0.181 g/210L of breath.

I charged Hickman with F.S.S. DUI Breath over 0.08. Hickman was booked into the Palm Beach County Jail.

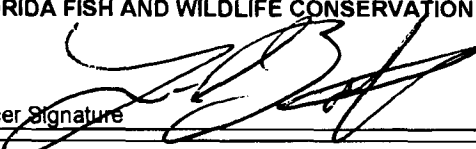

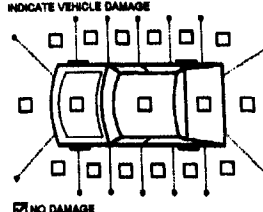
