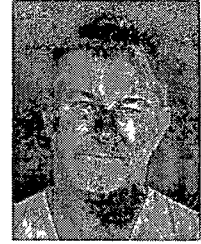

Before me this date personally appeared CARTER, JAMES W (1817) who being first duly sworn deposes and says that on 14 day of April, (year) 2022 at 2900 E COMMERCIAL BLVD, FORT LAUDERDALE, FL 33308 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

On April 13, 2022 at or about 2355 hours at 2900 E Commercial Blvd which is located within the jurisdictional limits of the City of Fort Lauderdale, within Broward County and the State of Florida, the above named defendant did commit the violation of Driving Under the Influence of alcoholic beverage (Florida State Statue 316 193) Christopher Prestera did, then and unlawfully drive, or was in actual physical control of a motor vehicle, to-wit Black Porsche bearing Florida tag GYPK92 while he was under the influence of an alcoholic beverage to the extent that his normal faculties were impaired or has a breath-alcohol level of 0 08 or more grams of alcohol per 210 liters of breath

On 04/13/2022, I was driving east on Commerical Blvd when I observed the listed Porsche accelerate rapidly to a high rate of speed The vehicle slowed down slightly and I was able to catch up and PACE clock the vehicle traveling at 62 MPH in a posted 35 MPH zone I conducted a traffic stop on the vehicle and I made contact with the driver and sole occupant, Prestera, in a parking lot in the area of 2900 E Commercial Blvd As I was approaching the driver side of the vehicle Prestera started to exit the vehicle until I told him to stay in the car Before I could say anything Prestera said I only had 1 beer I asked Prestera for his license, registration, and insurance and explained why I stopped him While speaking with Prestera I could smell the odor of an alcoholic beverage coming from his breath/person, his eyes were red/watery, his face was red/flush, and he had slurred speech

I asked Prestera to step out of the vehicle so I could speak with him and he complied. I explained that I was conducting a criminal D U I Investigation And I asked Prestera if he would submit to a series of field sobriety exercises, which he agreed to perform

Field Sobriety Exercise - Horizontal Gaze Nystagmus

The first exercise performed was the horizontal gaze nystagmus which was completed using a red pen light stimulus. The directions of the exercise were explained to Prestera I asked Prestera if he understood the directions of the exercise which she acknowledged he did I checked the eyes for equal pupil size, resting nystagmus, and equal tracking The exercise was performed starting with the subjects left eye and I observed the following clues in the left and right eye,

" Lack of smooth
" Distinct and sustained nystagmus at maximum deviation
" Onset of nystagmus prior to 45 degrees

The second exercise performed was a divided attention exercise, which was the walk and turn The walk and turn was performed using an actual line on a flat level dry surface free of debris The directions of the exercise were explained and demonstrated to Presterera at which time I asked Presterera if he understood Presterera responded "yes" I instructed Presterera to begin the exercise The following clues were observed,

- " Starts to soon
- " Stops walking to steady self
- " Misses heel-to-toe
- " Uses arms for balance, raising them over six inches
- " Improper turn

Field Sobriety Exercise - One Leg Stand

The third exercise performed was a divided attention exercise, which was the one leg stand The directions of the exercise were explained to Presterera at which time I asked him if he understood. Presterera responded "yes" Presterera was instructed to being the exercise at which time he lifted his right foot I observed the following clues,

- " Sways while balancing
