The vehicle slowed down slightly and I was able to catch up and PACE clock the vehicle traveling at 62 MPH in a posted 35 MPH zone I conducted a traffic stop on the vehicle and I made contact with the driver and sole occupant, Prestera, in a parking lot in the area of 2900 E Commercial Blvd As I was approaching the driver side of the vehicle Prestera started to exit the vehicle until I told him to stay in the car Before I could say anything Prestera said I only had 1 beer I asked Prestera for his license, registration, and insurance and explained why I stopped him While speaking with Prestera I could smell the odor of an alcoholic beverage coming from his breath/person, his eyes were red/watery, his face was red/flush, and he had slurred speech I asked Prestera to step out of the vehicle so I could speak with him and he complied.
