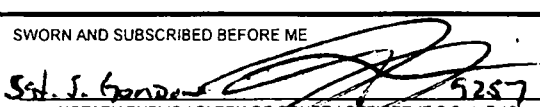
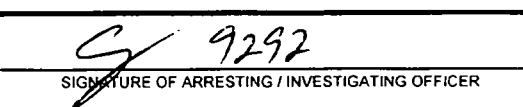

On the 21 day of May, 2022 at 09:00 (Specifically include facts constituting cause for arrest.) On 5/21/22 at approximately 0900 hrs, I arrested Eckert, Claire Elizabeth W/F DOB 04/04/1983 for Possession of Cocaine, F.S.S. 813.13(6)(A). The details are as follows: On 5/21/22 at approximately 0743 hrs, I responded to 101 Seminole Ave in reference to a trespass call. Upon arrival I met with the complainant who stated that she observed illegal activity of the above mentioned subject and a male later identified as, Atwood, Brandon John W/M DOB 12/28/1981, on her surveillance camera. The complainant showed responding officers the video in which you can see Eckert and Atwood sitting on the beach. Eckert can be seen drinking a can of Truly (alcoholic beverage), and exchanging a bag containing a white powder substance with Atwood. Alcohol on the beach is a town ordinance violation. Atwood can be seen inserting an object into the clear bag containing the white powder substance, then removes the object from the bag. When Atwood removed the object a white powder substance can be seen on it. Atwood then raises the object to his nose and appears to inhale the white powder substance. Responding officers made contact with both subjects on the beach and informed them of what was seen on the video. Eckert and Atwood were read miranda warnings, stated they understood their rights, and were were asked about the substance. Both Eckert and Atwood admitted the substance seen in the video was cocaine. A purse was next to Eckert when she was sitting on the beach. Eckert stated the purse belonged to her and she consented to a search of her person and the purse. In the purse were 3 clear bags with a white powder substance and a small red bag. Detective Mancino interviewed Eckert, and she admitted to buying \$200 worth of Cocaine the night prior. Eckert stated she purchased 4 small bags of cocaine. An officer on scene had a possible exposure with the substance reported to be cocaine, and collapsed. The officer was transported to a local hospital for a medical evaluation. Due to the possible exposure the substance was not field tested. The total packaged weight of all 4 bags was 4.6 grams.
