The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 The defendant was driving a red 2013 Hyundai four door bearing a Florida license plate of HFNV10. He made a right turn in front of a police officer that was traveling south on Bruce B Downs just north of I-75, and nearly caused a traffic crash by violating the right of way. As he traveled south on Bruce B Downs the defendant then failed to maintain his lane and nearly struck the officers vehicle again. A traffic stop was made at Bruce B Downs and I-75 and upon making contact with the defendant he displayed multiple indicators of impairment, to include; watery and bloodshot eyes, droopy eyelids, slurred speech, an odor of an alcoholic beverage, unsteady stance, and an admission to consuming alcohol (one beer). The defendant performed SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later submitted to a breath test which had a BrAC result of .248 and .254.

The defendant was identified by his FL DL.
