The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:  
On 06/11/2022 at approximately 0252 hours, at MacDinton's Bar located at 405 S Howard Ave, while being removed from the property the defendant, Coralys Torres-Perez, intentionally used her right hand to strike both victim #1, Tampa Police Officer J. Douillard and Victim #2 Tampa Police Officer A. Pitner.

The defendant was in a group that included both co-defendants, Angelo Cruz and Deivis Torres-Laino, that was being removed by MacDinton's Security due to their disruptive behavior. The defendant was verbally ordered by security and both victims to leave the property however the defendant refused to leave and willfully remained on the property. While Ofc. Douillard attempted to escort the defendant off the property, the defendant lunged at Ofc. Douillard and intentionally struck Ofc. Douillard in the face with her right fist causing minor injury. While Ofc. Douillard was attempting to place the defendant under arrest, the defendant used her closed right fist to strike the back of Ofc. A. Pitner's head as well as both of her eyes causing swelling and bruising to her face. The defendant continued to strike both victims as she was being placed under arrest. The defendant's actions were done intentionally, against the will of the victims and caused minor injury to both victims.

Both victim #1, Tampa Police Officer J. Douillard and Victim #2 Tampa Police Officer A. Pitner were working an extra duty assignment at MacDinton's Bar located at 405 S Howard Ave, both verbally identified themselves as Police Officers and were dressed in full "Class B" uniform with agency insignia.

The incident was witnessed by MacDinton's security officer Manuel Santiago who remained on scene and provided a sworn
