

On Wednesday October 12th 2022 at approximately 2243 I arrived on scene of a male passed out behind the steering wheel of his vehicle at 1005 N State Rd 7 (US 441) in the City of Royal Palm Beach, FL 33411 (Palm Beach County). Upon arrival I spoke with Investigator Ward ID# 16305 who relayed the following to me: I responded to the parking lot of Papichulo Tacons, 1005 N State Rd 7, in the village of Royal Palm Beach, Palm Beach County, in reference to a medical call, male passed out in a vehicle. Palm Beach County Fire Rescue and I arrived at the same time. Upon my arrival I observed a White Scion TC bearing FL tag IT22UN. The vehicle was pulled approximately halfway into a parking spot. There was a subject in the driver seat that appeared to be slumped over. I approached the vehicle on the driver side where I could smell the odor of an unknown alcoholic beverage coming from the vehicle with the doors and windows closed. ## OBSERVATION OF DRIVER:

I observed the defendant, Corey Edward Nedwick who was wearing a black tee shirt, gray shorts, and black sneakers. The defendant was standing outside his vehicle, leaning up against the front of Inv. Wards patrol vehicle. I asked the defendant to walk over to the front of my vehicle and speak with me. While walking over to my vehicle, the defendant was unsteady on his feet and staggered as he walked. While standing stationary the defendant swayed. He had a hard time standing in one position and moved around a lot. I could see the defendant's eyes were bloodshot and glossy. He had an obvious odor of an unknown alcoholic beverage emitting from his breath that grew stronger as he spoke. The defendant's speech was slow, slurred and unclear at times.

## DRIVER'S STATEMENTS:

The defendant said he did not have any physical defects or preexisting injuries, diabetes, or wear glasses. The defendant said he had 8 beers and run and soda to drink. In his vehicle were empty Bud Light Platinums, Steel Reserves and Mikes Hard Lemonade. The defendant said he was coming from the movies and fell asleep in his vehicle. I asked the defendant to submit to roadside field sobriety tasks to which he agreed. (Taylor) I said to the defendant, if you fail to submit to the roadside tasks I am requesting, it can be used against you in court. If you fail to submit to the roadside tasks I am requesting, I will be forced to conclude my investigation and base my decision as to your impairment solely on the facts at hand. He said he understood, he agreed to do the tasks.

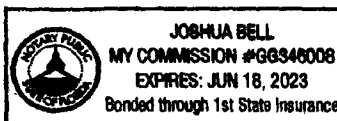

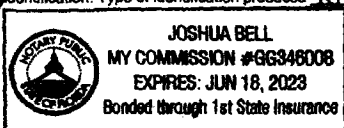

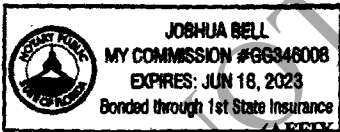
