On Saturday, July 16, 2022 at approximately 6:58 PM, I Corporal J. Dacosta (#1223) was conducting traffic enforcement in the 200 block of Country Club Drive. This is a two lane divided roadway, primarily residential with a posted 25 mph speed zone.

While in full Uniform and standing next to my marked Tequesta Police vehicle, I was utilizing a handheld radar unit to monitor traffic traveling North and South on Country Club Dr. I observed a gray sports utility vehicle traveling Northbound at a speed I visually estimated to be approximately 40 mph. I then activated the RADAR and received an audio Doppler tone which corresponded to my visual estimation. I then checked the target window and it showed a true speed of 44 mph. I stepped into the roadway and placed my hand out in front of me in a "Stop" gesture. The vehicle came to a complete stop approximately 10-12 feet away from me. I could see the driver through the front windshield without any obstructions. I pointed to the empty parking lot and instructed the driver to pull into it. The driver later identified by his Florida driver's license picture as Corey Lee Puckett (W/M DOB: 08/31/1994) turned the steering wheel to the left and accelerated around me. The vehicle continued Northbound on Country Club Dr.

I got into my Tequesta Police vehicle (Unit # 104) and activated my emergency equipment (lights and siren) and began to catch up to the gray SUV. As I got closer to the vehicle, it made a right turn onto Tequesta Circle. The vehicle continued to the end of the cul-de-sac where it pulled into the driveway of 252 Tequesta Circle. The driver exited the vehicle and ran on foot towards the rear of the abandoned residence. I advised dispatch that I had a vehicle fail to yield and the driver bailed out via my portable radio. I provided the Florida tag (97AQYC) displayed on the gray Lincoln MKC SUV. Dispatch advised the vehicle was registered to Corey Lee Puckett. A female later identified as Catherine Elise Carter (W/F DOB: 05/01/1998) by her Colorado driver's license exited the passenger side of the vehicle with her hands up. I instructed her to come back to my vehicle. I visually confirmed there were no more occupants inside the vehicle. I then returned to my vehicle and conducted a records check on Puckett. I positively identified Puckett as the driver of the vehicle by his driver's license picture.

Once the assisting Officers arrived on scene, a perimeter was established. Myself, Ofc. K. Norvil (#1225) and Detective D. Waychowsky (#1198) cleared the abandon residence. Tequesta K-9 Detective M. Loney (#1213) responded to the scene and attempted to track Puckett, to no avail. While searching for Puckett, I was advised by Martin County Deputy Sheriff P. Council that he was sitting outside Puckett's residence at 9364 SE Cove Point Street and he noticed a light turn on inside the house. Believing Puckett may be home, Det. Loney, Det. Waychowsky, Ofc. Norvil, and I responded to the residence and made contact with Deputy Council outside. We approached the residence and began knocking and announcing our presence. Det. Loney made contact with a woman who claimed to be Puckett's mother via the ring doorbell camera. She stated she was out of the state, however, she did not believe her son was home. After no response at the door, I returned back to the scene to retrieve a taped audio statement from Carter.

Carter provided a sworn recorded statement. Carter advised the driver was known to her as Corey Puckett (registered owner of the vehicle, and male I identified from a records check). Carter was then released from the scene to a responsible party who came to pick her up.

Vehicle towed by North County Wrecker Services and a hold was placed on the vehicle.

I believe probable cause exists to charge Corey Lee Puckett whom did willfully flee or attempt to elude a law enforcement officer in an authorized law enforcement patrol vehicle with agency insignia and other jurisdictional markings prominently displayed on the vehicle with siren and lights activated, contrary to Florida Statute 316.1935(2).
